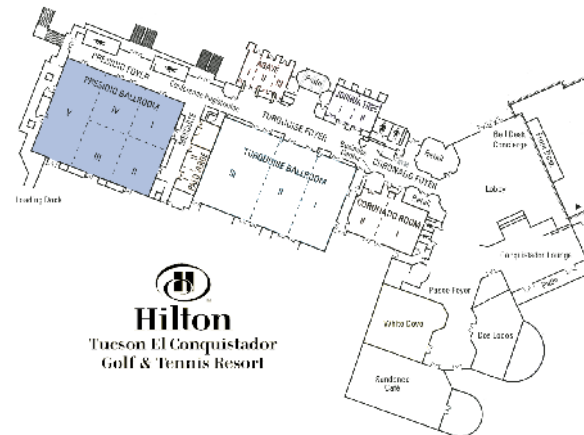

SouthWest Fest 2010 will draw approximately 100 top tax professionals from throughout Arizona and other states for two days of continuing education. This annual program of the Arizona Society of Enrolled Agents is the place to connect with Arizona Enrolled Agents.

Nationally renown tax expert Karen Brosi, EA, will headline the program, rounded out by a team of Arizona Enrolled Agents, a Certified Public Accountant, an attorney and IRS and Arizona tax officials.

Vendor booths will be situated in the ballroom foyer, where breaks will be held. Exhibitors will have opportunities to talk with participants during morning and afternoon breaks each day as well as during Thursday afternoon registration and at other times.

Vendors will be introduced to participants during a general session and will be listed in the participants' materials.
